CITIZEN ISSUE OF THE MONTH:

RATES & TARIFF INCREASES!

The Msunduzi Municipality called a public hearing on 16th March 2023 to review municipal rates and tariffs for 2023/2024. The meeting was lit! Thanks mainly to the MARRC affiliated residents' associations the council chamber was packed with people spilling over into the hall next door.

The mayor and the municipal manager had something more important to do so the meeting was chaired by the deputy mayor, Mxolisi Mkhize and the CFO, Nelisiwe Ngcobo

Rates are going up by 7%. Rates are not paid on the first R15 000 of the value of a property and people whose household income is less than R5 745 can apply, through a very complicated process – to not pay rates.

A trip to a swimming pool (when it is clean and open) will cost R140, using



sports fields will be unaffordable so the youth will have even less to do than they have now and turn to drugs. Community Policing Forums would not be able to afford to lease community halls for CPF meetings and crime would increase.

The CFO explained that these increases were implemented under section 74 of the Municipal Services Act no.32 of 2000 which says tariffs must reflect the costs reasonably associated with the rendering of the service.

Time was moving on and attendees' thoughts were starting to move from tariffs to their suppers.

The clear message from the meeting, other than that the residents are in for a nasty financial shock, is that there needs to be better communication between the municipality and it's residents.

As an active citizen your first step would be to join your local ratepayers' association.



SCOTTSVILLE RESIDENTS ASSOCIATION INAUGURAL MEETING 15th March 2023

It was a humid Maritzburg late summer evening. A small group of Scottsville residents gathered at St. Alpheges Hall. The ceiling fans whirled lazily overhead creating a faint breeze.

Where were all the other residents, the ones who complained on the chat groups if a dog barked twice? The meeting had been advertised extensively on social media. There had even been a minute notice in the Witness. An air of disappointment began to hang over the room.

Should the meeting continue? Kevin Beekrum from the Active Citizens Movement then said, "But

everyone we need is here – the MARRC committee, Anthony Waldhausen, Kantha Naidoo and Jacyn Fanner as well as all the people from Scottsville who cared enough to come out."

The mood of the meeting lifted - **YES, WE CAN!**

How could we use this collective energy to communicate with the residents of Scottsville? Suggestions flowed. Go back to basics and go door to door. Try the chat groups again. Design a pamphlet.

Think how to involve the students who live in the area. Identify community centres like churches and mosques. The small group of Scottsville residents was now enthused. Everyone at the meeting agreed to be on the interim Scottsville Residents Association committee and a chat group for action not complaining was set up.

So, Scottsville residents, look out and turn out for the next meeting of Scottsville residents. Be an active citizen, not just part of the people complaining.



RESIDENTS ASSOCIATION OF THE MONTH IMBALI RESIDENTS AND CIVICS ASSOCIATION

On the 1st of March 2009 the Imbali Unit 17 Residents Association was launched to negotiate with the ward

councillors and the municipality about the resident's local government needs.

As time has gone by residents in other areas of Imbali have seen what is being done in Unit 15 and asked to also be allowed to join.

On 7th of March 2002 the Imbali Residents and Civics Association was launched. With time each unit will have its own subcommittee.

The Imbali Residents and Civic Association faces many challenges. It seems that the municipality only pays attention when people burn tires.

There are child-headed households in the area and houses are sold as there are not proper title deeds. Some homes owe huge amounts in arrears which they cannot pay, and they are threatened with repossession.

I asked Mr. Khoza what life was like in Imbali. He replied it depended on the section. Unit 13 had been a very peaceful place, but it was also starting to see an increase in the crime which had spread through the other sections.

The main cause was the increase in drug use, which was even happening in the schools now. There were sports fields, but they had been damaged by floods and only the soccer fields were in use now. the path going down to the bridge to get to the field was not maintained by the municipality, so the residents had started to do it themselves.

Despite the many problems Mr Khoza felt that people in the community still loved one another and were prepared to help and support each other.

Postscript: Tragically 10 days after this interview Mr Khoza passed away suddenly on 22nd March 2023.

Mr Sithembiso Norman Khoza was born in Dalton in 1951.

His family moved to Ashdown in 1961.

He attended Ohlange High School in Inanda where he obtained his matric in 1971. He continued his studies at Fort Hare University in 1972 but became involved in the turbulent politics of the time and had to leave at the end of 1973.

He eventually completed his studies and then went to work in various positions in local government.

STEP ONE: Keep a record of when you

phoned (date & time), whether the call centre answered and your reference number.

STEP TWO: If the municipality does not

respond in a reasonable time, send the same information to your ward councillor, RRA to the manager responsible for the problem and to your area-based manager.

STEP THREE: If none of this resolves your problem, send the same information to

MARRC can use this information when advocating for better services from the municipality.



CURRENT NEWS:

A meeting was held in Shongweni outside Durban on Saturday 4 March 2023, with representatives from resident and ratepayer associations (RRAs) and civic organisations to discuss the formation of a broader group in KwaZulu-Natal.

The KZN RRA and civic group represents from across the province of KZN includes Pietermaritzburg, eThekwini, inland, and the North and South coasts. This also includes the eThekwini RRA, which is an umbrella body of 50 RRAs and civic organisations that covers Amanzimtoti to Hammarsdale.

The group added that while all members were part of a WhatsApp group, this was the first physical meeting of the group where they were able to share challenges, successes



and learn from each other.

It was agreed at the meeting to formalise the group into the KZN Civic Movement that will comprise all resident and ratepayer associations and civic organisations throughout KZN.
